#37-17 – Additional appropriation within the Auditor's Certification-Commissioners to appropriate to Severance (Sheriff). Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

#38-17 – Additional appropriation within the Auditor's Certification-Commissioners to appropriate to Special Improvement Ditch (Western Meadows). Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

The commissioners signed a travel request for the Landfill and a letter of support for the BRWP. Brian Robertson made the motion for the chairman's signature on the certificate of the total amount from all sources available for expenditures and balances form from the Auditor's office, Timothy Bechtol seconded. Motion passed 3-0.

The clerk presented the following resolution for consideration for the Assistant Prosecutor:

#39-17 – Sale of public property no longer needed by the Hancock County Board of Developmental Disabilities. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Philip Johnson presented the following resolution for consideration:

#40-17 – Authorizing assistance to HATS in the acquisition of grant funds and materials through the Ohio Department of Transportation's acquisitions program by entry into contract for the benefit of HATS, pursuant to the Ohio Revised Code 5513.01, ET SEQ. They received a grant for \$197,000. They have the ability to acquire this through ODOT procurement system but only if the county is the contracting party. The money would be used to purchase materials and

equipment to upgrade computer and communications systems and install back-up cameras in their vehicles. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Steve Wilson had nothing to report.
