INSTRUCTIONS FOR HANCOCK COUNTY DOG LICENSES:

**IT'S THE LAW
(ORC 955.01)**

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.
(The law applies regardless of whether the dog is kept inside or out.)

ON-LINE

Register your dog on-line at www.doglicenses.us/OH/Hancock. Credit card payments only; per license convenience fee applies. To access your pre-filled form you will need your Account ID and Password listed below.

IN PERSON OR BY MAIL

1. Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
3. Enclose a check or money order for the correct fees payable to: **Hancock County Treasurer**. Please do not send cash. **Before January 31**, licensing rate is **\$20.00 per dog**. **After January 31**, statutory late penalty increases the licensing rate to **\$40.00 per dog**. Your application cannot be processed without the correct fees.
4. Please return the application and check or money order to the above address. A receipt will be returned to you with your 2021 license tag(s).

You may purchase kennel licenses in person at Hancock County Auditor's Office at 300 S. Main St, Rm 22.

Certificates of registration and registration tags shall be valid only during the CALENDAR YEAR or YEARS for which they are issued. ORC Sec 955.09.

Dogs may be registered for a 1 year or 3 year term, or permanently. Complete each line of the application for your dog(s). In particular, choose your "Term" (1 Year, 3 Year or Permanent - see term codes below) and fill in "Fee Paid" based on the fee structure to the right of this paragraph. 3 Year and Permanent License may only be purchased by mail or in person at the Hancock County Auditor's office.

THIS FORM IS DESIGNED TO ENABLE YOU TO REGISTER YOUR DOG(S) BY MAIL ACCORDING TO OHIO LAW EVERY PERSON WHO OWNS, KEEPS, OR HARBORS A DOG MORE THAN THREE MONTHS OF AGE, SHALL ON OR AFTER THE FIRST DAY OF DECEMBER, BUT ON OR BEFORE THE 31ST DAY OF JANUARY OF EACH YEAR, REGISTER THEIR DOG(S) WITH THE COUNTY AUDITOR.

FOR YOUR CONVENIENCE, WE HAVE INCLUDED A DOG LICENSE APPLICATION AND AN ENVELOPE, WHICH YOU MAY COMPLETE AND RETURN WITH YOUR PAYMENT. IF YOU OWN DOGS IN ADDITION TO THOSE LISTED PLEASE FILL IN ALL INFORMATION ON BLANK LINES PROVIDED ON APPLICATION FORM. SCHEDULE OF FEES IS PRINTED ON ENCLOSED APPLICATION.

INSTRUCTIONS

1. COMPLETE ATTACHED APPLICATION AND RETURN WITH A SELF-ADDRESSED, STAMPED ENVELOPE). ***PLEASE INDICATE CHANGE OF ADDRESS ON APPLICATION IN SPACE BESIDE COMPUTER PRINTED NAME AND ADDRESS.**
2. IF PHONE NUMBER IS INCORRECT OR DOES NOT APPEAR ON APPLICATION, PLEASE PROVIDE CORRECT INFORMATION.
3. MAKE CHECK OR MONEY ORDER PAYABLE TO: **HANCOCK COUNTY TREASURER**
4. PLACE CHECK OR MONEY ORDER AND COMPLETED APPLICATION WITH SELF-ADDRESSED, STAMPED ENVELOPE IN RETURN ENVELOPE.
5. DO NOT SEND CASH

ALL LAWS PERTAINING TO DOGS, INCLUDING THE LICENSING OF DOGS, MAY BE FOUND IN CHAPTER 955 OF THE OHIO REVISED CODE. SECTION 955.10. **TAGS TO BE WORN.** NO OWNER OF A DOG, EXCEPT A DOG CONSTANTLY CONFINED TO A REGISTERED KENNEL, SHALL FAIL TO REQUIRE THE DOG TO WEAR, AT ALL TIMES, A VALID TAG ISSUED IN CONNECTION WITH A CERTIFICATE OF REGISTRATION. A DOG'S FAILURE AT ANY TIME TO WEAR A VALID TAG SHALL BE PRIMA-FACIE EVIDENCE OF LACK OF REGISTRATION AND SHALL SUBJECT ANY DOG FOUND NOT WEARING SUCH TAG TO IMPOUNDING, SALE, OR DESTRUCTION.
