Commissioner Bechtol asked if the board has any jurisdiction over that. Steve Wilson stated they have no jurisdiction. This would fall to zoning and the township and most of this is being done in Washington Township.

He stated last year at this time we had a lot of doubt about how to move forward but we have now got the building going and getting closer to having the benching done. There are a lot of good things going on for the county.
