Resolution #90-19 – Transfer of funds from Indigent Defense to the General Fund (January 2019)-\$1,485.82. Mark Gazarek made the motion to approve, Brian Robertson seconded. Motion passed 3-0.

Resolution #91-19 – Transfer of funds within the appropriation – Job & Family-General Office. Mark Gazarek made the motion to approve, Brian Robertson seconded. Motion passed 3-0.

Resolution #92-19 – Transfer of funds from Job & Family-General Office to Children Services. Mark Gazarek made the motion to approve, Brian Robertson seconded. Motion passed 3-0.

Resolution #93-19 – Transfer of funds from Job & Family-General Office to Children Services. Mark Gazarek made the motion to approve, Brian Robertson seconded. Motion passed 3-0.

Resolution #94-19 – Transfer of funds from Sanitary Landfill to Landfill Bond Retirement. Mark Gazarek made the motion to approve, Brian Robertson seconded. Motion passed 3-0.

Lucinda Land presented the following resolution for consideration:

Resolution #95-19 – A resolution authorizing Hancock County to apply for, accept, and enter into a Water Pollution Control Loan Fund agreement on behalf of the County of Hancock for the

repair and replacement of home sewage treatment systems. Mark Gazarek made the motion to approve, Brian Robertson seconded. Motion passed 3-0.

Superintendent Mark Kowalski from Liberty-Benton Schools invited the Commissioners to attend their State of the School presentation on March 11. The school has a levy on the ballot in order to pay for a \$45.6 million project that would mainly consist of replacing the PreK-8th grade building.

Meetings/Reports

Brian Robertson attended the Alliance Board meeting and the Liberty-Benton Chicken Fry fundraiser. He requested executive session to discuss potential real estate acquisition.

Mark Gazarek thanked Trent Land for his work on getting a video together to promote and educate on glass recycling at Litter Landing.
