Resolution #17-19 – Hancock County appointment of County Engineer, Douglas E. Cade, PE, PS, as the representative and Ben Lindhorst as alternate representative for Hancock County on the District 13 OPWC Integrating Committee. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #18-19 – Amending Resolution No. 550-18 – Authorizing a contract with Robin Kershner, D/B/A Kershner Excavating for the design and installation of a new home sewage treatment system as part of the Hancock County WPCLF Grant WPCLF Project #HS390032-003-2018-4. The original completion date was November 10, 2018, but the contractor was unable to complete the project by that date. Hancock Public Health requested an extension to January 30, 2019. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #19-19 – Sale of property no longer needed by Hancock County. The landfill no longer needs a 1979 Dodge truck. The value is less than \$2,500. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #20-19 — A resolution pursuant to Sections 5705.19 and 5705.222 of the Revised Code, requesting the Hancock County Auditor to certify the yield for a proposed five year renewal 2.5 mill levy to be placed on the May 7, 2019 ballot for community developmental disabilities programs and services and capital improvements of the Hancock County Board of Developmental Disabilities. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Adam Witteman and Doug Cade had nothing to report.
