Michael Pepple stated on Wednesday all three Commissioners attended the Northwest Ohio Commissioners and Engineers meeting in Bucyrus. There was a very good discussion. Last night all three Commissioners attended the Hancock County Region 17 OneOhio Organizational meeting. They were able to get all organized, pass the bylaws and select the Region 17 representative.

Timothy Bechtol confirmed he attended the other two meetings. He has also been in communications with the architects for the Judicial Center. There has been a meeting request from the Auditor in regards to the IT equipment at the new building. There was a discussion on the on the bidding process and what would be needed to restrict what is put in for the new building's IT equipment. Commissioner Bechtol will follow up with Tim Stuart on what is needed and relay all information to the architects.
