Minutes November 3, 2020

The Commissioners signed the Explosive Gas Monitoring Report for the Sanitary Landfill. Also, they approved a travel request from the Sheriff's Office.

Lucinda Land presented the following resolutions for consideration:

Resolution #864-20 — Authorizing Change Order No. 2 to the contract with Smith Paving & Excavating Inc. for construction of the Village of McComb Sidewalk project pursuant to the provisions and regulations associated with a CDBG project. The installation of additional sidewalks will add \$11,583 making the total project cost \$44,000. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 2-0.

Resolution #865-20 – Authorizing the Hancock County Commissioners in conjunction with the HCJFS to enter into a Memorandum of Understanding between HCJFS and Allen County Children Services Board for reimbursement for the cost of Allen County children in Hancock County care. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 2-0.

Philip Johnson presented the following resolution for consideration:

Resolution #866-20 – Authorizing entry into second amendment to contract with A1 Land Development, LLC for demolition of buildings located at 321 Clinton Court in Findlay. This extends the deadline to November 30, 2020. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 2-0.

Resolution #867-20 — Authorizing the establishment of a "No Engine Brake" Zone along a portion of County Road 313 in Liberty Township. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 2-0.

Meetings/Reports

Timothy Bechtol visited Litter Landing on Friday to observe operations. He attended a Zoom meeting with Mayor Muryn regarding COVID cases. The Mayor stated the message for containment needs to come from more than the Mayor's office, Hospital, and Hancock Public Health. He also pointed out the tremendous importance of Election Day.

Brian Robertson is hoping people continue with a peaceful election process. He thanked the two Commissioner candidates at today's meeting. Brian stated it takes courage and heart to put your name on the ballot.

At 11:00 a.m. the Commissioners met with Randall Galbraith for a JFS Update. Sarah Mutchler and Adam Witteman were also present. Randall gave an update on the placement costs coalition. They will be meeting today for a presentation from Franklin County on placement cost containment. He also provided statistics on the Ohio Means Jobs/Economic Development Partnership. He made a request to have the Friday after Thanksgiving off. The Commissioners agreed. Randall requested an executive session to discuss pending litigation. At 11:05 Brian Robertson made the motion to enter into executive session to discuss pending litigation, Timothy Bechtol seconded. A roll call vote resulted as follows: Brian Robertson, yes; Timothy Bechtol, yes. At 11:12 a.m. Brian Robertson made the motion to come out of executive session with no action taken, Timothy Bechtol seconded. Motion passed 2-0.
