Resolution #789-19 – Additional appropriation within the Auditor's certification – Commissioners to appropriate to Contingencies. Brian Robertson made a motion to approve, Mark Gazarek seconded. Motion passed 3-0.

Brian Robertson made a motion to approve the Warrant Journal, Mark Gazarek seconded. Motion passed 3 -0. Two travel requests were signed for the Treasurer, along with payroll for JFS. Brian Robertson made a motion for Timothy Bechtol to sign a cost allocation plan prepared by Maximus Inc. for FY 2019. Mark Gazarek seconded. Motion passed 3-0. Resolution #790-19 – Resolution providing for the issuance and sale of not to exceed \$750,000 of notes, in anticipation of the issuance of bonds, for the purpose of paying costs of acquiring a trash compactor for use by the County Landfill. Brian Robertson made a motion to approve, Mark Gazarek seconded. Motion passed 3-0.

Resolution #791-19 – Resolution providing for the issuance and sale of not to exceed \$2,000,000 of notes, in anticipation of the issuance of bonds, for the purpose of paying a portion of the costs of constructing, furnishing, equipping and otherwise improving a new building to house the functions of the County Probate, Juvenile and other courts and clearing, improving and equipping its site. Brian Robertson made a motion to approve, Timothy Bechtol seconded. Motion passed 2-1. Mark Gazarek voted no.

Phil Johnson presented the following resolution for consideration:

Resolution #792-19 – Authorizing signature to and submission of documents to Ohio Office of Community Development. Brian Robertson made a motion to approve, Mark Gazarek seconded. Motion passed 3-0.

Charity Rauschenberg announced that the Budget Commission did meet and signed the estimated revenue. There was some discussion on prisoner housing and indigent expense due to some budget changes down at the State. Economic Development met today and gave an update on flood benching and different transportation corridors.
