Minutes October 9, 2018

Commissioner Robertson opened the meeting at 9:30 a.m. in the Commissioners' 1st floor conference room. The Pledge of Allegiance was recited. Minutes from the October 4, 2018 meeting were read with Mark Gazarek making the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #651-18 – Additional appropriation within the Auditor's certification-Commissioners to appropriate to Local Law Enforcement Block Grant. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

The Commissioners approved travel requests from Job & Family Services and the Recorder's office.

Lucinda Land presented the following resolutions for consideration:

Resolution #652-18 – Authorizing a contract with A&D Excavating, LLC for the design and installation of a new home sewage treatment system as part of the Hancock County WPCLF Grant WPCLF Project #HS390032-003-2018-3. This is an 85/15 split project. The property owner has paid their share. The total project cost is \$11,303. The contract total is \$10,500. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #653-18 – Resolution authorizing the Hancock County Commissioners to authorizing payment to Soil & Environmental Consulting Services, Inc. for soil investigation for onsite sewage treatment suitability for eligible WPCLF properties. The cost is \$350 for WPCLF Project #HS390032-003-2018-7. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #654-18 — Authorizing Change Order No. 1 to the contract with Zimmerman Paint Contractors, Co., Fremont, Ohio, for the 2018 County/Township Pavement Marking Program.

The Change Order is for an additional \$1,300, making the total contract cost \$47,250. Mark Gazarek made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Curt Smith said the phones have been implemented and the first invoice from TSC should be coming soon. He also reported the Fiber Loop project is approximately 90% complete. He estimates the project will come in for less than originally anticipated.

Meetings/Reports

Mark Gazarek attended the groundbreaking ceremony for the Hydraulic Improvement Project on the Blanchard River. He also met with representatives from BVHS to discuss the opiate epidemic. He requested executive session to discuss personnel in regards to hiring.

Timothy Bechtol also attended the groundbreaking ceremony for the Hydraulic Improvement Project on the Blanchard River. He attended the AIA State Convention and led a panel discussion on being an architect and a public servant. He also stated there are several Then & Now letters this week that have amounts over \$5,000. He would like to see that change.

Brian Robertson is continuing to draft an overview of expenditure and capital needs. He would like to get input from Auditor Rauschenberg before sending the information to the Elected Officials.

At 9:49 a.m. Brian Robertson made the motion to enter into executive session to discuss personnel in regards to hiring, Mark Gazarek seconded. A roll call vote resulted as follows: Brian Robertson, yes; Mark Gazarek, yes; Timothy Bechtol, yes. At 10:15 a.m. Brian Robertson made the motion to come out of executive session with no action taken, Mark Gazarek seconded. Motion passed 3-0.

At 11:00 a.m. the Commissioners met with Judge Starn, Judge Miller, and Judge Hackenberg to discuss State Issue #1. Jim Maurer was also present. The Judges requested the Commissioners publicly state opposition of State Issue #1. Several Nonpartisan groups have opposed the issue, including CCAO. While Judge Starn did not disagree that the jail is not a place to treat drug addiction, the information being given regarding State Issue #1 is incorrect and the goals set out are not achievable if State Issue #1 is passed. The Commissioners agreed to prepare a resolution stating their opposition of State Issue #1. Judge Miller stated he would work with Prosecutor Riegle and/or Lucinda Land regarding the wording in the resolution.
