Minutes September 15, 2020

Resolution #688-20 — Transfer of funds within the appropriation-Sheriff. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #689-20 – Additional appropriation within the Auditor's certification-Commissioners to appropriate to Alcohol, Drug Addiction, and Mental Health Services. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #690-20 – Transfer of funds within the appropriation-Job & Family Services. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #691-20 – Additional appropriation within the Auditor's certification-Commissioners to appropriate to MV>. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #692-20 — Additional appropriation within the Auditor's certification-Commissioners to appropriate to the General Fund. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Lucinda Land presented the following resolutions for consideration:

Resolution #693-20 — Authorization of the third amendment to Resolution No. 537-18 and authorization of a purchase order for payment of \$113,845.35 for reimbursement to the Maumee Watershed Conservancy District, pursuant to a certain Memorandum of Agreement between the Maumee Watershed Conservancy District and the Board of Hancock County Commissioners for hydraulic improvements to the Blanchard River. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Resolution #694-20 — Resolution authorizing the Hancock County Commissioners to enter into an amendment to the contract with the Hancock Hardin Wyandot Putnam Community Action

Commission (HHWPCAC), to provide necessary transportation service for the TANF/PRC Transportation program for Head Start. This would extend the period of service through September 30, 2021 and add \$140,000 to the contract. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Lucinda requested an executive session to discuss threatened litigation. Philip Johnson requested an executive session to discuss potential litigation.

Philip Johnson presented the following resolution for consideration:

Resolution #695-20 – Authorizing the grant, execution, and recording of an easement agreement with Roger Best and John Best in relation to water flow and drainage near County Road 9 in Liberty Township, Hancock County. This would be for a 40 foot strip on the East side of County Road 9. Engineer Cade has approved the plan and requests their approval on the easement. Mark asked if Philip Johnson had gotten Doug's signature of approval. Philip Johnson had nothing in his possession with Engineer Cade's signature. Brian Robertson made the motion to approve with the stipulation that Engineer Cade send a letter of approval, Timothy Bechtol seconded. Motion passed 3-0.

Adam Witteman had nothing to report.

Brian Robertson had a discussion with Mr. Haywood and Mr. Mayle regarding the Blanchard Valley Port Authority.
